

GENERAL INFORMATION

Check with the clerk of the Court for the appropriate providers name, phone number and program location.

In all cases, you must have a successful completion report from the provider before your driving privileges may be restored.

Successful completion per RSA 265-A:42 means:

- Consistent and on time attendance
- Participation in the program
- Fees paid in full
- Completion of any additional aftercare requirements as determined necessary by the program provider

These aftercare requirements may include one or more of the following:

- Individual or group outpatient treatment (both at your own expense)
- Residential treatment (at your own expense)
- Documented attendance at self-help groups.

CAUTION

If you complete the wrong program, you will have to repeat the process. This means additional expense and further delays in the restoration of your driving privileges.

By law, your license/operating privileges **CANNOT BE RESTORED UNTIL YOU HAVE SUCCESSFULLY COMPLETED THE PROPER PROGRAM AND AFTERCARE.**

IMPORTANT

The law provides substantial penalties for driving after revocation of your driving privileges.

Penalties for driving after Revocation for DWI (RSA 263:64 IV) shall be:

- Guilty of a misdemeanor
- Sentenced to imprisonment for a period not less than 7 consecutive 24-hour periods.
- Fined not more than \$1,000.00
- Have his/her license or privilege revoked for an additional year.

DO NOT BRING

- Alcohol or other substances
- Food or drink
- Weapons of any kind
- Electronic equipment; cell phones, pagers, computers cameras, video games or DVD players. (Radios with headphones/batteries are OK)
- Non-prescribed medications
- Perfumes, aftershave, mouthwash

IMPORTANT INSTRUCTIONS FOR THE DRIVER CONVICTED OF DWI



The State of New Hampshire has three separate programs for individuals convicted of DWI. The one you must attend is mandated by law and will depend on your offense. Full payment is expected when you enter the program. If you need to make other financial arrangements, you must do so prior to entrance into the program.

On-line or telephone programs do not meet the requirements of NH statutes and rules.

Selecting the right program is your responsibility.

The court may reduce revocation time if you enter into the relevant driver intervention program within 45 days after conviction.

PROGRAM I

IMPAIRED DRIVER INTERVENTION PROGRAM (IDIP) OR WEEKEND IMPAIRED DRIVER INTERVENTION PROGRAM (WIDIP) FOR THE FIRST OFFENDER (class B misdemeanor).

If you have been convicted of a DWI first offense and have had no other DWI convictions in this or any other state in the last 10 years, you are considered a first offender and belong in an IDIP or WIDIP.

IDIP and WIDIP programs are 22 hours in duration and consist of the following:

- One hour intake interview
- 20 hours of alcohol and other drug education classes
- One hour exit evaluation and assessment interview by a NH LADC
- Possible aftercare recommendations that must be followed before eligibility for license restoration

The IDIP consists of sessions held weeknights or all day on consecutive Saturdays or Sundays plus two individual interviews. Currently the fee is \$460.00, subject to change without notice.

The WIDIP is a concentrated version of the IDIP, scheduled Friday afternoon until late Sunday afternoon and requires two overnight stays. Current fee is \$585.00, which includes the cost of room and board. Fee is subject to change without notice.

PROGRAM II

PHASE II RESIDENTIAL PROGRAM FOR THE REPEAT OFFENDER (class A misdemeanor).

If you have been convicted of more than one DWI first offense in any state in the last 10 years, you must complete the Phase II program.

Phase II Program consists of the following:

- An intensive seven day and night residential program
- Focus on alcohol and other drug education, group interaction and self-assessment
- All clients are evaluated by the end of the program
- Any aftercare recommendations must be completed before license restoration eligibility

Current fee is \$1550.00, subject to change without notice.

PROGRAM III

MULTIPLE OFFENDER PROGRAM (MOP) FOR THE SECOND, SUBSEQUENT OR AGGRAVATED OFFENDER (class A misdemeanor or class B felony depending on the circumstances).

If you have been convicted of a second (or subsequent) offense, or an aggravated DWI, you will receive a minimum 10 day sentence from the court. The first three days will be served at the House of Corrections (HOC) (unless you were sentenced to more than the minimum). This will begin on Tuesday and end on Friday. You will be transported from the HOC to the MOP Intervention Detention Center in Laconia NH for the remaining seven days. You will be released the following Friday morning, and you must arrange for your own transportation (unless you must return to the HOC).

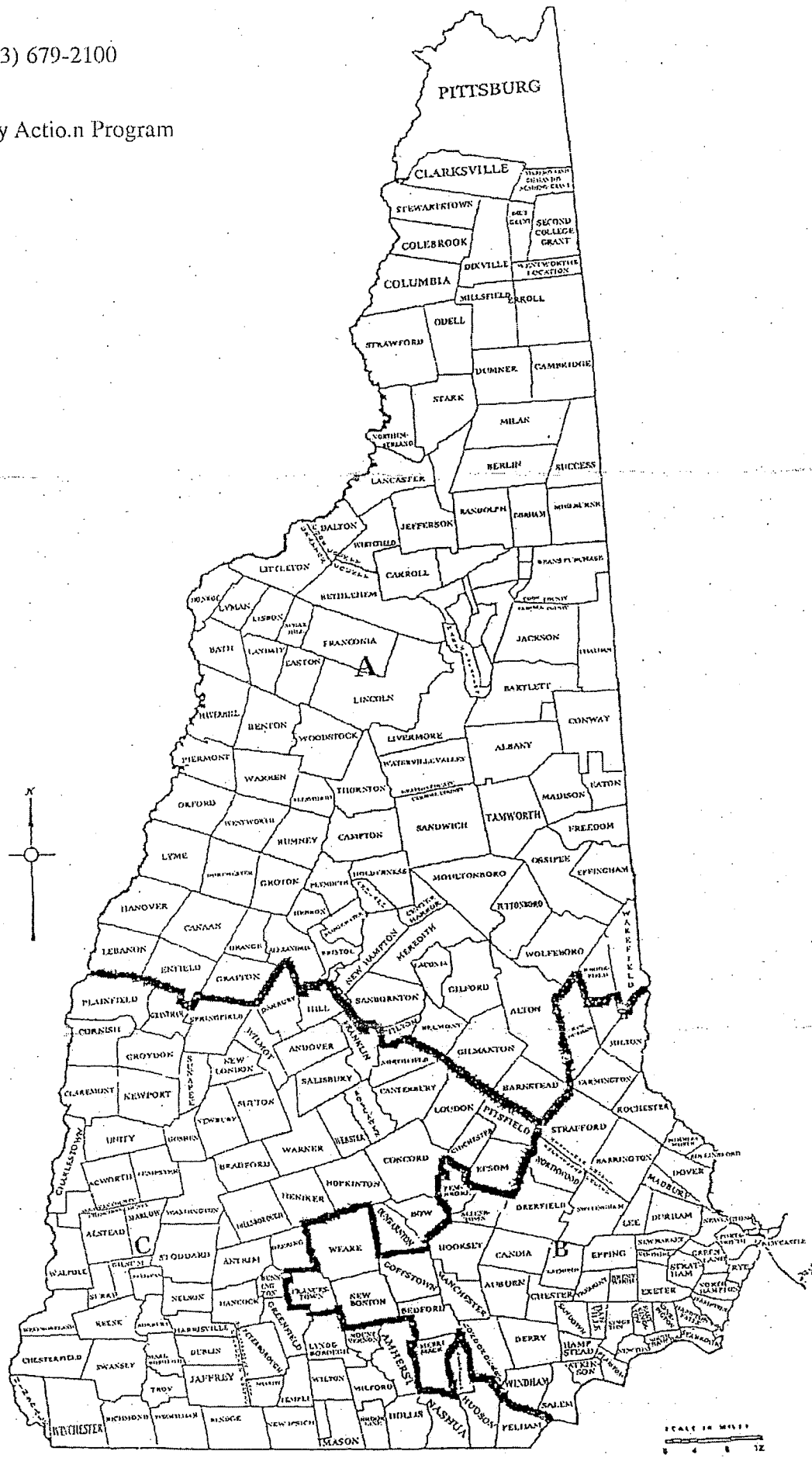
MOP consists of the following:

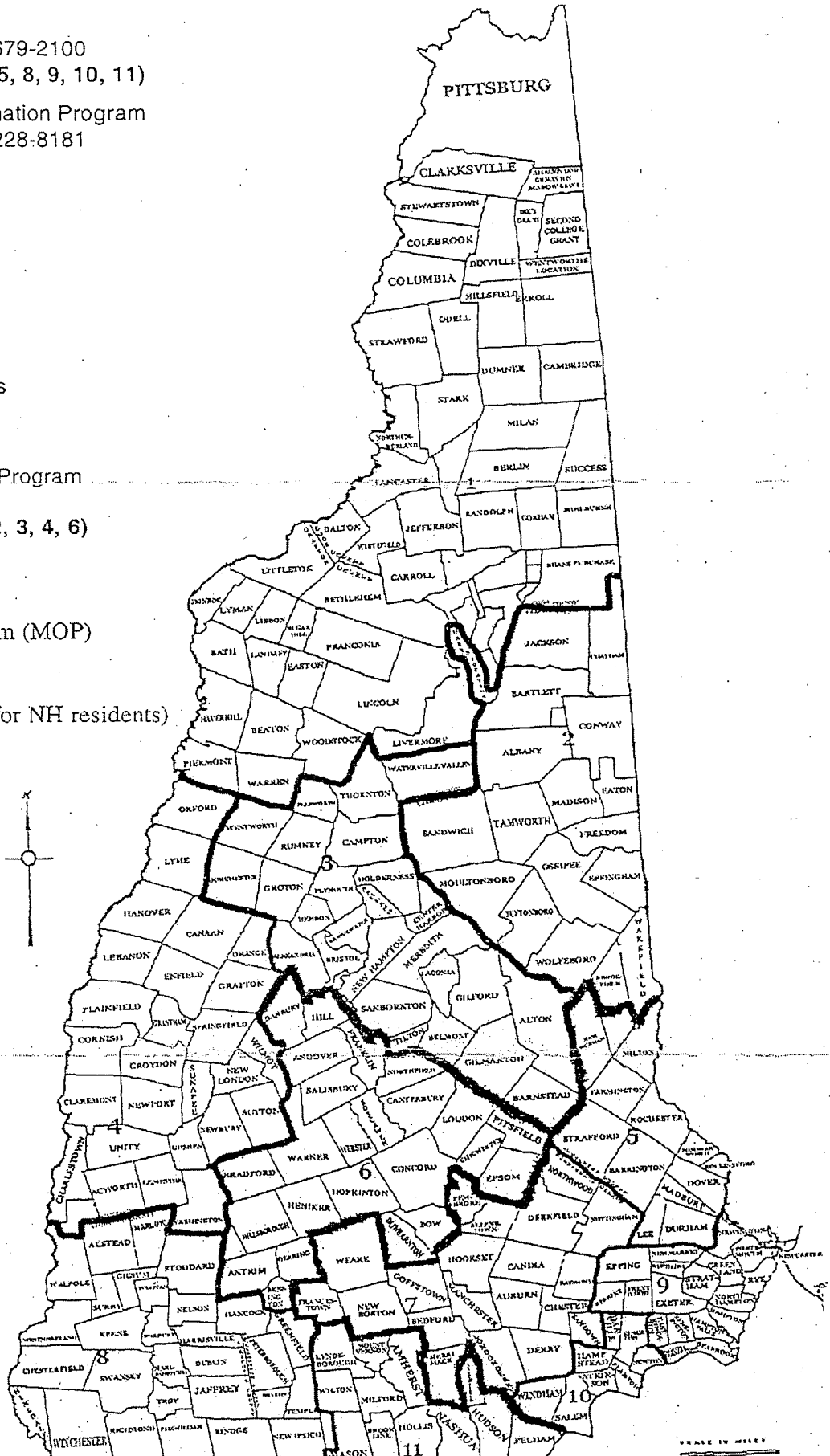
